the question of the American identity is left open. Left open for any one vocal group to try to claim it.


The solution, or part of the solution I offer is a Multi-faith religious center is a potential solution. It keeps each faith distinct, while validating it's existence. It then also gives opportunity to all to observe the conduct of a religion and allows people to draw their own conclusions. It is also a neutral space within a large city that is able to be helpful to visitors.

Building is a plant for: Education, Exposure, Worship, Validation, and Story telling.

The building acts as one of the many nodes in Central Park NYC, leading people in due to it's prominent locations. Once inside the building there is a raised walkway that offers a neutral manner to see the temple, style of worship, and gain a higher understanding of other cultures.

The five religious groups are loosely tied with a neutral, profane space that encourages interaction between groups. A mediator in the place of meditation.

The Religions are stationary, the people physically move, and the ideas metaphorically move.


New York City was and remains to be a historic cultural landing pad for the old world to enter the new world, with all of the opportunity it offered. Today, many people's first American city remains to be New York. due to it's access to international travel.

Subsequently, Central park is the moment of relief in a concrete jungle. The Park was previously a large forest before it was a city, and then it was a series of housing, up to and including Seneca Village.

Over time the space was purchased slowly and converted into a forested public park area filled with points of interest. These points range from public entertainment venues, shrines, fountains, playgrounds and sports arenas.

Just south of The Lake, a man made lake is a hill named Cherry Hill, This location is world famous for it's Blooming Cherry Trees cover the space in white pedals.

This location, which has direct views of The Lake, the Bethesda fountain, The ever-evolving trees, direct access to vehicular traffic, all while being in a moment of relief in a prominent city make this site desirable to carry out this design.




The building occupies the site on a small projection facing the water. On the sloped site, the higher level meets the temple level, whereas the basement level meets with the water.

The entire building is rotated 18.5 degrees, as to allow the Mosque face Mecca, and the Synagogue face Jerusalem. This rotation also forces the Buddhist temple to be in closer proximity to the Blossoming Cherry trees to the West.

In response also, the Church then was rotated to face true east, which is a characteristic found in traditional churches and cathedrals. There are three stained windows that do an additional rotation that turn and face Bethesda Fountain, a callback to the fountains of life found in the Bible.

The proximity of the building to New York City is to have the building pushed into and centralized in the park space to minimize noise, a gesture towards meditation.

Finally, the building is perceivablea from many of the park nodes, and is close to the walkways. As Central Park sees over 5,000 visitors in a day during tourist season, and is a popular location throughout the winter, the temple would be connected to the community at all times.


BUILDING

There are five religious temples located in this structure. As they are, they are space spaces for those who want to worship what they worship, but they are in coversation with each other.


Between the temples is a profane space of connection. The negative space is the house of communication, the piece that is not seen in other contemporary temples.


LIVING and PERFORMANCE




Within a multi-faith society, we at a legal level accept that other religions are free to exist.


However, within each temple there may be an inherent inclination to create "the echo chamber" effect wherein one's own value of their faith eclipses the respect they have for their neighbors faith.
